1 Plaintiffs D.T., Jane Doe, and Helen Roe (“Plaintiffs”) and Defendants Dr. Cara
2 Christ, Thomas Salow, and Krystal Colburn (“Defendants”) (collectively, “Parties”), by
3 and through their respective counsel, hereby state as follows:

4 1. Counsel for the Parties conferred by telephone and email on November 25,
5 2020, to continue their discussions concerning the possibility of resolving Jane Doe’s
6 Motion for Preliminary Injunction (Doc. 3) without the need for the currently scheduled
7 Preliminary Injunction Hearing.

8 2. The Parties have tentatively agreed that Jane Doe will request from the
9 Court an A.R.S. § 36-337(A)(4) order ordering Defendants to amend the sex/gender field
10 on Jane Doe’s birth certificate. Defendants will take no position on Jane Doe’s request or
11 as to whether Jane Doe has met the necessary standards under A.R.S. § 36-337(A)(4) to
12 obtain an order ordering Defendants to amend the sex/gender field on Jane Doe’s birth
13 certificate.

14 3. Defendants will agree to promptly process Jane Doe’s/Susan Doe’s
15 complete and compliant application to amend Jane Doe’s birth certificate.

16 4. The Parties anticipate being able to resolve Jane Doe’s Motion for
17 Preliminary Injunction (Doc. 3) without the need for a Preliminary Injunction Hearing.

18 5. The Parties anticipate providing the Court with a joint stipulation and
19 proposed order by Friday, November 27, 2020.
