1 Plaintiffs D.T., Jane Doe, and Helen Roe (“Plaintiffs”) and Defendants Dr. Cara  
2 Christ, Thomas Salow, and Krystal Colburn (“Defendants”) (collectively, “Parties”), by and  
3 through their respective counsel, provide notice to the Court and stipulate as follows:

4 1. The Parties conferred several times last week in their successful efforts to  
5 resolve Plaintiff Jane Doe’s Motion for Preliminary Injunction. (Docs. 39, 40.) At the same  
6 time, the Parties also conferred about and agreed upon how to proceed in the next stage of  
7 the litigation, and now jointly seek this Court’s approval of the resulting proposal.

8 2. Plaintiffs intend to amend their Complaint (Doc. 1) as permitted by Federal  
9 Rule of Civil Procedure 15(a)(1)(B). Plaintiffs seek additional time to file their amended  
10 complaint and request leave to file it on or before January 8, 2021. Defendants do not object  
11 to this request.

12 3. Defendants seek additional time to respond to Plaintiffs’ amended complaint  
13 and request leave to file a responsive pleading within thirty (30) days of the filing and  
14 service of the amended complaint. Plaintiffs do not object to this request.

15 **STIPULATION**

16 WHEREFORE, the Parties hereby stipulate and agree that the Court should enter an  
17 order vacating any and all pending deadlines, setting the deadline for Plaintiffs to file an  
18 amended complaint for January 8, 2021, and extending the deadline for Defendants to file  
19 a responsive pleading to no later than thirty (30) days after Plaintiffs file and serve the  
20 amended complaint.
