1 Plaintiffs Helen Roe, James Poe, and Carl Voe (“Plaintiffs”), by and through their
2 counsel, hereby request a status conference with the Court. On May 12, 2021, counsel for
3 Plaintiffs first informed counsel for Defendant that at least one of the Plaintiffs would
4 require an amended birth certificate in the next few months and requested that Defendant
5 agree to a stipulation like the one the Parties entered for Jane Doe. *See* Doc. 41. On June
6 22, at Plaintiffs’ request, counsel for the Parties conferred by telephone to discuss Carl
7 Voe’s impending need to obtain a birth certificate consistent with his gender identity before
8 he enrolls in school in September 2021.

9 Before Plaintiffs formally move the Court for any form of relief and given that
10 Defendant’s Motion to Dismiss is still pending, Plaintiffs request the opportunity to seek
11 guidance from the Court on the best path forward in a status conference at the Court’s
12 convenience.
