1 Defendants take no position on Plaintiffs' request for a status conference.
2 Defendants will, however, object to a Motion for Preliminary Injunction seeking an
3 amended birth certificate for an additional named Plaintiff, which Plaintiffs alluded to in
4 their Request, in part because that Plaintiff abandoned his state court petition to amend his
5 birth certificate after joining this case, which is incongruous with any current claimed
6 urgency for an amended birth certificate. Defendants will also object to any briefing
7 while Defendants' Motion to Dismiss (Doc. 56) this lawsuit remains pending. If the Court
8 wishes to hold a status conference, in the interest of judicial economy and to conserve the
9 parties' resources, Defendants request that the status conference occur after the Motion to
10 Dismiss is decided, but no earlier than July 16, 2021, to avoid scheduling conflicts.
