1 Plaintiffs Helen Roe, James Poe, and Carl Voe (“Plaintiffs”), by and through their  
2 counsel, respectfully file this reply in support of their request for a status conference.  
3 Doc. 73. Plaintiffs note that Defendants do not object to a status conference on this time-  
4 sensitive matter.  
5

6 Defendants’ objection to a possible motion for preliminary injunction for Carl Voe,  
7 including Defendants’ incorrect assertion that Carl “abandoned his state court petition to  
8 amend his birth certificate after joining this case,” Doc. 75 at 2, is at best premature given  
9 that no motion has been filed. However, the possible necessity for such a motion is one of  
10 the many moving pieces that prompted Plaintiffs to request a status conference with the  
11 Court. Another piece is Plaintiffs’ forthcoming motion for class certification, which  
12 Plaintiffs have thus far chosen to delay filing until after this Court’s ruling on Defendants’  
13 motion to dismiss. Plaintiffs have attempted to address many of these interconnected issues  
14 directly with Defendants, to no avail.

17 Holding a status conference at this early juncture will provide much-needed clarity  
18 to the parties as the litigation moves into the next phase. Plaintiffs are available for such a  
19 conference at the Court’s earliest convenience.
