**JOINT MOTION TO ALTER DEADLINES RELATING TO PLAINTIFFS'
MOTION FOR ATTORNEY'S FEES**

Pursuant to Local Civil Rule 7, the parties jointly move to amend the briefing and argument schedule relating to Plaintiffs' motion for attorney's fees, for which there is good cause.

On August 5, 2022, Plaintiffs filed a motion for attorney's fees and costs. *Harrison* ECF No. 328; *Roe* ECF No. 342. Plaintiffs noticed the hearing date for that motion for September 16, 2022, *see Harrison* ECF No. 330; *Roe* ECF No. 344, and the Court accordingly set the hearing for that date, *see* Aug. 8, 2022 Docket Notice. However, Plaintiffs now have a

conflict with the September 16 hearing date.

By operation of Local Civil Rule 7(F)(1), Defendants' brief in response to Plaintiffs' motion is currently due on August 19, 2022. To respond to Plaintiffs' motion, counsel for Defendants must review hundreds of pages of billing records. Defendants respectfully state that they need additional time to fully review these billing records, confer further with Plaintiffs, and to otherwise prepare their response to Plaintiffs' motion for fees.

The parties have met and conferred and have jointly agreed to the following briefing and argument schedule. The parties further agree to waive any hearing or oral argument on this motion. The parties respectfully propose that the Court enter an order setting the following schedule concerning Plaintiffs' motion for attorney's fees:

- **September 9, 2022.** Defendants file their response brief.
- **September 20, 2022.** Plaintiffs file their reply brief.
- **September 23, 2022.** Hearing on motion.
