**PLAINTIFF'S NOTICE OF WITHDRAWAL OF MOTIONS FOR PRELIMINARY
INJUNCTION (ECF NO. 50) AND FOR PROTECTIVE ORDER (ECF NO. 51)**

On August 1, 2022, Plaintiff was released from Coastal State Prison and is no longer in the custody of the Georgia Department of Corrections. Plaintiff agrees that her claims for declaratory and injunctive relief are now moot and due to be dismissed without prejudice. *See Wahl v. McIver*, 773 F.2d 1169, 1174 (11th Cir. 1985) (dismissal without prejudice is appropriate where injunctive claims become moot by an inmate's transfer or release). Therefore, Plaintiff hereby gives notice of the withdrawal of her Motion for Preliminary Injunction (ECF No. 50), which was consolidated with the trial on the merits (ECF No. 143), and her Motion for Protective Order (ECF No. 51).
