**AFFIDAVIT OF RAMSAY BULKELEY, EXECUTIVE DIRECTOR,
PALM BEACH COUNTY
PLANNING, ZONING, AND BUILDING DEPARTMENT**

1. My name is Ramsay Bulkeley. I am sui juris, and have personal knowledge of the facts set forth herein.
2. I am the Executive Director of the Palm Beach County (the County) Planning, Zoning, and Building Department (PZ&B).
3. Code Enforcement, a Division within PZ&B, is the County Division assigned to enforce the County's Prohibition of Conversion Therapy on Minor Ordinance, (the Ordinance), which was enacted on December 21, 2017, and codified at Chapter 18, Article V, Section 18-121, et seq., Palm Beach County Code, ordinance No. 2017-046.
4. The County is a Home Rule Charter County created pursuant to Article VIII, Section 1 of the Florida Constitution.
5. The County is governed by the seven-member Palm Beach County Board of County Commissioners ("the Board").
6. Verdenia Baker, the County Administrator, is the chief executive officer of the County.

She has held this position since 2015.

7. From the time of the enactment of the Ordinance, to date, the County's PZ&B Code Enforcement Division has received no complaints regarding conduct that falls within the conduct prohibited by the Ordinance, nor has the Code Enforcement Division conducted any investigations regarding therapists who were alleged to be engaging in conduct prohibited by the Ordinance.

8. On August 12, 2022, I received the attached MEMORANDUM from Verdenia Baker, County Administrator, advising that the Federal Court has held the Ordinance to be unconstitutional, and advising me that the Board will be considering its repeal at its meeting of August 23, 2022; therefore, there will be no enforcement of the Ordinance.
