**JOINT MOTION TO AMEND THE
SCHEDULING ORDER**

1 The parties respectfully move the Court to amend the Court’s Scheduling Order. In
2 support of this motion, the parties state as follows:

3 1. This Court’s May 18, 2022 order extending the temporary suspension of
4 scheduling order dates (Doc. 268) directed the parties to “confer in good faith in an effort to
5 devise a mutually agreeable briefing schedule for dispositive motions,” within 30 days of a
6 ruling on the State Defendants’ Motion for Reconsideration (Doc. 261). The parties were
7 also directed to file a joint motion to amend the scheduling order with seven days of
8 conferring.

9 2. On August 9, 2022, this Court ruled on State Defendants’ Motion for
10 Reconsideration (Doc. 278), and lifted the Court’s stay.

11 3. Pursuant to this Court’s May 18, 2022 Order, the parties have met and conferred
12 regarding a dispositive motion schedule, and have agreed on a mutually acceptable schedule.

13 4. As such, the parties respectfully request that this Court issue a scheduling order
14 directing the following:

- 15 • All dispositive motions shall be filed no later than September 26, 2022.
- 16 • All responses to dispositive motions shall be filed no later than October 26,
17 2022.
- 18 • All replies in support of dispositive motions shall be filed no later than
19 November 23, 2022.
- 20 • A joint proposed pretrial order shall be lodged 30 days after resolution of
21 dispositive motions.
