1 As explained in prior joint status reports, the United States has appealed to the U.S. Court
2 of Appeals for the Fifth Circuit from the order and permanent injunction issued in *Texas v. United*
3 *States*, No. 1:18-cv-00068, ECF Nos. 575, 576 (S.D. Tex. July 16, 2021). That court heard oral
4 argument on July 6, 2022, but has not yet ruled. Pursuant to this Court's March 23, 2021 Order,
5 ECF No. 319, the parties will file another joint status report on or before November 21, 2022, and
