**Motion to Maintain Document Under Seal**

Plaintiff, by counsel, says that:

1. On this date he has filed his Request that this Court take judicial notice of an order from the Monroe Circuit Court VI that granted him a change in his gender marker.
2. A redacted copy of the order was publicly filed and the unredacted version has been filed under seal pursuant to Local Rule 5-11.
3. Plaintiff requests that the unredacted copy of the change of gender marker order be maintained under seal.
4. By order of the Monroe Circuit Court VI., dated June 27, 2022, public access to the records of the state court change of gender marker proceeding and all other public access to the proceeding were prohibited.

5. The order of the Monroe Circuit Court VI granting plaintiff a gender-marker change contains his actual name and his mother's actual name.

6. The plaintiff is proceeding in this litigation by his initials pursuant to Fed. R. Civ. P. 5.2(a)(3).

7. Plaintiff's mother, who is his next friend in this litigation, is proceeding by her initials pursuant to this Court's Order of December 20, 2021. (Dkt. 23).

8. In order to preserve the anonymity of the plaintiff and his mother, plaintiff request that the unredacted copy of the order granting him a change of gender marker be maintained under seal.

WHEREFORE, plaintiff requests that the unredacted copy of the order granting him a change of gender marker be maintained under seal, and for all other proper relief.
