

1 avoid unnecessary discovery during that time. Additionally, Plaintiffs have filed a
 2 motion to amend the complaint to convert the litigation into a class action, and require
 3 additional discovery in support of their anticipated class action motion. Defendant will
 4 oppose the motion to amend.
