"A permit is required for special events on private property that changes the "use" of that property. We often see this come up when a commercially zoned property wants to do something in their parking lot but the event temporarily reduces the number of parking spaces required by the building code. So the permit is required so law enforcement and the fire department can ensure that the event can be done with any health, safety, ingress and egress issues being adequately addressed. If you have legal counsel that wants to give me a call, then I would be happy to answer any other questions. And yes, when Red Cliffs Mall does an event in their parking lot, then they get a special event so we can ensure that health/safety/traffic concerns are covered."

We ask for detailed maps because IF there was ever an emergency, we need to know where things are and how to get around. Some events can use a major area for runs and all sorts of things. We have Fire and Police sign off for those reasons as well.

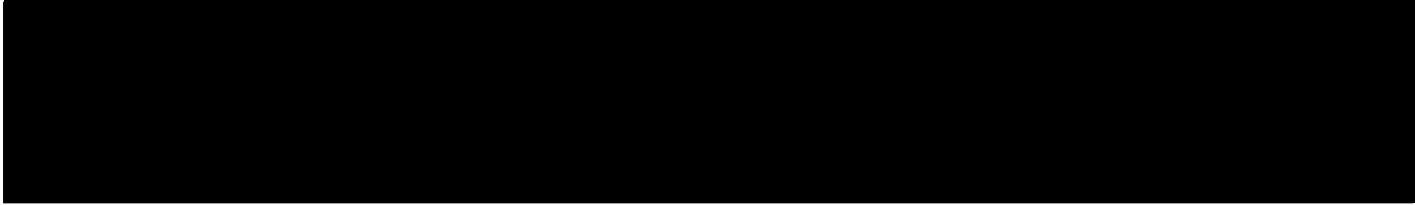
