DEFENDANTS' MOTION TO FILE UNDER SEAL

Pursuant to Local Civil Rule 5, Defendants move to seal unredacted versions of Exhibits 7, 9, 10, and 11 that are being filed in support of Defendants' Opposition to Plaintiffs' Motion to Enforce Judgment and for an Order to Show Cause, which is being filed concurrently with this motion. These exhibits contain information that could potentially be used to identify the pseudonymous individuals living with HIV that are discussed in Plaintiffs' motion and Defendant's response. Defendants believe that some of the currently redacted information is likely not sufficiently identifying to warrant continued sealing, but out of an abundance of caution Defendants have moved to seal the unredacted exhibits in order to allow time for Plaintiffs to evaluate the unredacted exhibits and inform the Court whether Plaintiffs

to Enforce Judgment and for an Order to Show Cause (.e., Exhibits 7, 9, 10, and 11) are and shall remain **UNDER SEAL** pending further order of the Court.
